## 1. Call to Order

Dave Crabb called the meeting to order at 6:10 pm

### 2. Adoption of Agenda

Gus Wruck moved adoption of the agenda. Seconded by Rilla Britton.

# **3.** Adoption of Minutes

Financial information in March, 2011 minutes too brief for members' understanding. Rilla Britton moved that more information on the Financial Report be included in the minutes. Seconded by Lorne Britton. Motion carried.

## 4. Financial Report

Jim Nicholson provided Financial Report as of March 31, 2011 to members. Moved by Jim that the summary at the bottom of the Financial Report be included in the minutes from now on. Seconded by Marion Jones. Motion carried. (see attached financial summary taken from report).

## 5. Business and Action Items Arising From the Minutes

#### **6.** Old Business

- **a.** Eastern Beaches Coalition Conservation website contains all the letters re EBCC (over 50). No conclusion until the snow melts. Development in limbo.
- **b.** Website: The member associations are now up on the website. A replica of the School Tax Sign is now showing on the website with information on how to obtain a sign.
- c. School Taxes:
  - i. Motion put forward by Larry Baker that MACO contact all cottage associations and ask that, for this year only, on a voluntary basis, they send a \$2.00 per member donation to assist with the promotion of the elimination of education taxes during the 2011 provincial election. Seconded by Lorne Britton. Motion passed.
  - ii. Motion by Gus Wruck that municipalities each be asked to donate, on a voluntary and one-time basis, \$50/\$150/\$250 for a small medium, or large population to assist with the promotion of education tax elimination in this election year. Seconded by Lorne Britton. Motion passed. Gus Wruck to provide a template for use in soliciting donations. (see attached.)
  - **iii.** Motion by Larry Baker that Education Tax Elimination signs be available to directors at \$3.00 per sign and to the public at \$4.00 a sign. Seconded by Rilla Britton. Motion passed. Larry Baker has a meeting planned with Heather Stefanson to discuss the tax rally.
  - iv. Gus distributed a letter to the editor in the Lac du Bonnet Leader written by Carolyn Giles. The letter pointed out the unfairness of the current education tax, the inequity of "inside the park tax" and calculations on how a 1% increase in sales tax would benefit an "outside the park" resident. Gus Wruck moved that this letter be published on the MACO website. Seconded by Marian Jones. Motion carried.

- **d.** Lake Winnipeg Levels nothing to report.
- e. Revised Membership Categories:
  - i. "Cottage Associations \$1.00 per member minimum \$30.00

- **ii.** Individual \$20.00
- iii. Municipal \$50.00 small/\$150.00 medium/\$250.00 (based on size and number of cottages)
- **iv.** Corporate \$300.00
- **v.** Associate \$20.00
- vi. The above motion was moved by Gus Wruck and seconded by Lorne Britton. Motion carried.
- **vii.** Moved by Jim Neufeld that advertising costs will not be included in Bylaw #2. Seconded by Larry Baker. Motion Carried.
- **f.** Is MACO green? Tabled to next meeting.
- g. Disaster Compensation: sub-committee Pat Dunlop, Bob Cox and Norma Kerr met regarding Disaster Compensation. Purpose of sub- sub-committee is to advocate for a more equitable method of distributing DFA funds. Cottage associations in other provinces to be contacted to get proper contact information, obtain their information and ideas, and most of all, to obtain their support in the initiative. A letter will then go out to all provincial candidates, newspapers, radio stations (i.e. Richard Cloutier). There will be an attempt to obtain either a letter of support or signed petition from cottage associations across Canada, including, Manitoba. A copy of Pat Dunlop's letter to Vic Toews will be put on the website. As well, Larry Baker will be meeting with James Bezan, MP Selkirk/Interlake re DFA. Norma suggested the name "Disaster Compensation" be changed to "Equitable DFA Assistance" (or "Non-Discriminatory DFA Assistance."
- **h.** Charitable Status: Gus Wruck provided information on charitable status from a handbook on *Charitable Purpose Advocacy and the Income Tax Act* that defined charitable status and clearly showed MACO cannot be a charitable organization.

#### 7. New Business

- **a.** MACO image problem: Discussion on how to promote elimination of education taxes as a property owners' issue, and not just a MACO issue. Suggestion to set up a subsidiary association that includes property owners in the title and has an appropriate acronym. This will be on the next agenda. Members to think about process and name.
- **b.** Strategic Plan Review: Gus Wruck read out sections of MACO's Strategic Plan and it was agreed that directors would read the Strategic Plan and spend most of the next meeting reviewing it and brainstorm how, what and who will complete the tasks. This will be imperative for the next meeting as the election is approaching.

# 8. Correspondence Received/Responded to

- **a.** Letter from Louise Charette of the CBC asking what MACO knows about the situation in Hollow Water. Government is not doing anything for cottagers who do not have any information on how to get to or protect their cottages. MACO unable to help as MACO has no information either.
- **b.** Cottage Country.com: Cottage Country would like to put a business card size ad on the front of MACO's website. A motion by Gus Wruck to allow the ad and charge a fee of \$100.00 per month, with some discretion to Dave when he meets with the owner. Seconded by Lorne Britton. Motion passed.
- c. International Water Safety Inflatable vests: MACO will promote. MACO will do an issue summary and put it on the website under Issues. Rilla Britton agreed to drive this issue.

### 9. Directors' Reports

- a. Directors' Reports were given.
  - i. Marion would like a phone committee to call everyone who received the newsletter. Marion suggested a common message that included: getting proper contact information; mentioning MACO's advocacy on education tax and non-discriminatory DFA assistance; a suggestion to look at MACO's website and its benefits to all re: health, safety and protection of cottage owners; request a donation of \$50.00/\$150.00/\$250.00 depending on size of association for assistance with advocacy for elimination of education tax from property tax bills.
  - **ii.** There was a suggestion that if directors' reports contained anything that should be in the minutes, it should be given to the secretary in writing.

**a.** Next meeting dates are Tuesdays, May 17, June 21, July 19, August 16, September 20, October 4, and November 15. No meeting in December. AGM to be determined.
