Gus Wruck – Fournier Drive Association AGM confirmed association will continue. Guest Gerald Hawranik and Don Sikora. Thursday did a presentation to council meeting regarding senior housing. End of August did a trip north to Gimli, Grindstone, Arborg & Dauphin area. Visited an original Ukrainian homestead about 10 mi. north of Gilbert Plains. All buildings were built from logs except the garage. Near Plumas there are 2 or 3 Amish farms.

Rilla Britton – Awaiting feedback on RM survey. Consensus to guide RM on priorities. Approximately \$875,000 for infrastructure

Federal/Provincial/RM #1 priority is Twin Lakes Beach road. Hasn't seen documentation yet.

Dave Crabb Outlined that RM of St. Clements is trying to charge a resident not within an improvement area for upgrade costs. Lake Winnipeg Action Committee re lake levels. Erosion is worse. Work on Balsam Harbour to strengthen docks. RM vigorously patrol and educate ATV operators. Time will tell if there will be a positive outcome. It is a little quieter as it appears that they are going to the trails.
