9. **Directors' Reports**

Dave Crabb — Development proposal to RM of St. Clements. Informed that this is a priority for RM's this year however, due to flood issues no final results. Have received additional donations. Advised Mary Strang of problem with area septic system — Conservation found that the system was non compliant, was never registered, near lake, bordering neighbours, no septic reports available and there are shallow wells. Province refuses to do anything.

Lorne Britton – Dr. Goldsborough Lake Manitoba Stewardship Board met regarding a survey of 1 mile of the lake. The RM of St. Laurent and RM

of Woodlands were sharing costs on roads by exchanging roads for maintenance. In January the agreement was torn up. Under threat of a legal opinion the agreement is in effect again.

Marian Jones — Was out to the lake the last 2 weekends with the last melts and the heavy rainwater paths seem well worn. Three areas are washing away on roads. The runoff is due to poor drainage and left several inches of ice in the garage. The wildlife is out.

Gus Wruck — Fournier Drive Association is concerned regarding one property where there is sewer drainage into river. Ice is out. Water treatment plant not enough customers, may be running further lines. Another \$16,000 donated to Lac du Bonnet Community Foundation.

Donna Jean Crabb – Was out at lake the past weekend. A fitness and wellness centre may be built. There is a proposal by Destination Grand Marais. Vote being taken.

Larry Baker – Having problem with drainage at both the cottage and at home.

Pat Dunlop – No report.

Gary Dunlop – No report.

Shirley Nixon – The Municipal Board made a decision that the \$240,000 debenture for the RM of St. Laurent is to be shared by mill rate. Cannot assess a flat rate per property.
